For the purpose of designating the Greater Faith Baptist Church, 3000-3004 Huntingdon Avenue, as an historical landmark: exterior.

By adding

Article 6 - Historical and Architectural Preservation

Section(s) 17A-37

Baltimore City Code

(Edition 2000)

Section 1. Be it ordained by the Mayor and City Council of Baltimore, That the Laws of Baltimore City read as follows:

Baltimore City Code

Article 6. Historical and Architectural Preservation

Subtitle 17A. Landmark List: Exteriors - 2010s

§ 17A-37. Greater Faith Baptist Church.

Greater Faith Baptist Church, 3000-3004 Huntingdon Avenue.

Section 2. And be it further ordained, That the catchlines contained in this Ordinance are not law and may not be considered to have been enacted as a part of this or any prior Ordinance.

Section 3. And be it further ordained, That this Ordinance takes effect on the 30th day after the date it is enacted.
