### **Discounted City Services and Equipment for Nonprofit Events**

For the purpose of requiring that the City grant a 50% discount for City services and equipment used to support a nonprofit event; and generally relating to the provision of City support to nonprofit events.

By adding

Article 1 - Mayor, City Council, and Municipal AgenciesSection(s) 37-1 and 37-2, to be under the new subtitle designation "Subtitle 37. Nonprofit Event Discount"Baltimore City Code(Edition 2000)

Section 1. Be it ordained by the Mayor and City Council of Baltimore, That the Laws of Baltimore City read as follows:

# **Baltimore City Code**

# Article 1. Mayor, City Council, and Municipal Agencies

#### Subtitle 37. Nonprofit Event Discount

#### § 37-1. Discount on City services and equipment costs for nonprofit events.

(a) In general.

If the net proceeds from any event are to be used exclusively for the benefit of a nonprofit, tax-exempt charitable or religious organization, the fees for City services or equipment used to support the event must be reduced by 50% from the otherwise applicable rate.

(b) *Documentation to be provided*.

The sponsoring organization must submit satisfactory evidence documenting its qualifications for the discount provided by this section at the time that it requests City services or equipment for its event.

#### § 37-2. Rules and regulations.

(a) In general.

The Director of Finance may adopt rules and regulations to carry out this subtitle.

(b) Copies to be filed with Legislative Reference.

A copy of all rules and regulations adopted under this section must be filed with the Department of Legislative Reference before they become effective.

Section 2. And be it further ordained, That the catchlines contained in this Ordinance are not law and

may not be considered to have been enacted as a part of this or any prior Ordinance.

Section 3. And be it further ordained, That this Ordinance takes effect on the 30<sup>th</sup> day after the date it is enacted.
