# City of Baltimore Council Bill

## A Bill Entitled

An Ordinance concerning Zoning - Legislative Authorizations - Corrective

For the purpose of deleting a Council-hearing deadline that fails to account for the required procedures and time-frames for seeking and obtaining preliminary agency reviews and reports to the Council; providing for a special effective date; and generally relating to Council procedures for bills proposing legislative authorizations.

By repealing and reordaining

Article 32 - Zoning Section 5-507(a)(1) Baltimore City Code (Edition 2000)

Section 1. Be it ordained by the Mayor and City Council of Baltimore, That the Laws of Baltimore City read as follows:

#### **Baltimore City Code**

#### Article 32. Zoning

#### Title 5. Applications and Authorizations

#### Subtitle 5. Legislative Authorizations

#### § 5-507. Action by City Council.

- (a) *Committee hearing.* 
  - The bill must be considered at a public hearing of a committee of the City Council[, to be held within 90 days of the introduction]. Notice of the public hearing must be given in accordance with Title 5, Subtitle 6 {"Notices"}.

Section 2. And be it further ordained, That the catchlines contained in this Ordinance are not law and may not be considered to have been enacted as a part of this or any prior Ordinance.

Section 3. And be it further ordained, That this Ordinance takes effect when it is enacted, retroactive to June 5, 2017.
