Recitals

The revenue appropriated by this Ordinance represents funds from the Fund Balance in excess of the revenue relied on by the Board of Estimates in determining the tax levy required to balance the budget for Fiscal Year 2018.

This additional revenue could not have been reasonably anticipated when the Ordinance of Estimates for Fiscal Year 2018 was formulated.

This appropriation is made necessary by a material change in circumstances since the Ordinance of Estimates for Fiscal Year 2018 was formulated or is for a new program that could not have been reasonably anticipated when that Ordinance of Estimates was formulated.

On , the Board of Estimates recommended this appropriation to the City Council.

Section 1. Be it ordained by the Mayor and City Council of Baltimore, That \$3,000,000 shall be made available to the Baltimore City Public Schools - Service 352 (Baltimore City Public Schools) as a Supplementary General Fund Operating Appropriation for Fiscal Year 2018, to provide funding for additional operating expenses. The source of revenue for this appropriation is funds from the Fund Balance in excess of the amount from this source that was relied on by the Board of Estimates in determining the tax levy required to balance the budget for Fiscal Year 2018.

Section 2. And be it further ordained, That this Ordinance takes effect on July 2, 2017.
