For the purpose of designating the Metropolitan United Methodist Church, 1119 and 1123 West Lanvale Street, as an historical landmark: exterior.

By adding

Article 6 - Historical and Architectural Preservation Section(s) 17A-45
Baltimore City Code (Edition 2000)

Section 1. Be it ordained by the Mayor and City Council of Baltimore, That the Laws of Baltimore City read as follows:

Baltimore City Code

Article 6. Historical and Architectural Preservation

Subtitle 17A. Landmark List: Exteriors - 2010s

§ 17A-45. Metropolitan United Methodist Church.

Metropolitan United Methodist Church, 1119 and 1123 West Lanvale Street.

- **Section 2.** And be it further ordained, That the catchlines contained in this Ordinance are not law and may not be considered to have been enacted as a part of this or any prior Ordinance.
- Section 3. And be it further ordained, That this Ordinance takes effect on the 30th day after the date it is enacted.
