By adding

Article 6 - Historical and Architectural Preservation

Section(s) 17A-45

Baltimore City Code

(Edition 2000)

Section 1. Be it ordained by the Mayor and City Council of Baltimore, That the Laws of Baltimore City read as follows:

Baltimore City Code

Article 6. Historical and Architectural Preservation

Subtitle 17A. Landmark List: Exteriors - 2010s

§ 17A-45. Metropolitan United Methodist Church.

Metropolitan United Methodist Church, 1119 and 1123 West Lanvale Street.

Section 2. And be it further ordained, That the catchlines contained in this Ordinance are not law and may not be considered to have been enacted as a part of this or any prior Ordinance.

Section 3. And be it further ordained, That this Ordinance takes effect on the 30th day after the date it is enacted.
