**Section 1. Be it ordained by the Mayor and City Council of Baltimore,** That the name of Radecke Park, located at 5602 Radecke Avenue, is changed to Ralph Sears Fields at Radecke Park.

**Section 2. And be it further ordained,** That this Ordinance takes effect on the 30<sup>th</sup> day after the date it is enacted.
