An Ordinance concerning

#### City Property - Renaming Radecke Park to Ralph Sears Fields at Radecke Park

For the purpose of changing the name of Radecke Park, located at 5602 Radecke Avenue, to Ralph Sears Fields at Radecke Park.

By authority of

Article 5 - Finance, Property, and Procurement Section 20-2 Baltimore City Code (Edition 2000)

**Section 1. Be it ordained by the Mayor and City Council of Baltimore**, That the name of Radecke Park, located at 5602 Radecke Avenue, is changed to Ralph Sears Fields at Radecke Park.

Section 2. And be it further ordained, That this Ordinance takes effect on the 30<sup>th</sup> day after the date it is enacted.
