### Repeal of Uplands Renewal Area and Plan

For the purpose of repealing Ordinance 04-887, as amended by Ordinance 08-99, which established the Uplands Renewal Area and Plan; and providing for a special effective date.

By repealing  
Ordinance 04-887

**Section 1. Be it ordained by the Mayor and City Council of Baltimore,** That Ordinance 04-887, which established the Uplands Renewal Area and Plan, as amended by Ordinance 08-99, is repealed.

**Section 2. And be it further ordained,** That this Ordinance takes effect on the date it is enacted.
