Section 1. Be it ordained by the Mayor and City Council of Baltimore, That the footbridge, located approximately 100 feet north of University Parkway over Stoney Run, is named the Amy Mickel Footbridge.

Section 2. And be it further ordained, That this Ordinance takes effect on the 30th day after the date it is enacted.
