Article 5 - Finance, Property, and Procurement

Section 20-2

Baltimore City Code

(Edition 2000)

**Section 1. Be it ordained by the Mayor and City Council of Baltimore,** That the name of Lyndhurst Elementary/Middle School Building, located at 621 Wildwood Parkway, is changed to Wildwood Elementary/Middle School Building.

**Section 2. And be it further ordained,** That this Ordinance takes effect on the 30<sup>th</sup> day after the date it is enacted.
