# A Bill Entitled

### An Ordinance concerning

#### **Commercial Vehicle Monitoring System**

For the purpose of modifying the governing standards of Baltimore City's commercial vehicle monitoring system.

By repealing and reordaining with amendments Article 31 - Transit and Traffic Section(s) 34-3 Baltimore City Code (Edition 2000)

**Section 1. Be it ordained by the Mayor and City Council of Baltimore**, That the Laws of Baltimore City read as follows:

### **Baltimore City Code**

#### Article 31. Transit and Traffic

#### Subtitle 34. Commercial Vehicle Monitoring System

#### § 34-3. Governing standards, etc.

[(a) In general.]

A commercial vehicle monitoring system may not be used except in accordance with and subject to the prerequisites, standards, procedures, requirements, limitations, and other provisions of:

- (1) the State Enabling Law; and
- (2) this subtitle and the rules and regulations adopted under this subtitle.
- [(b) Maximum number of operational cameras.]

[No more than 6 cameras may be operational at any one time.]

Section 2. And be it further ordained, That the catchlines contained in this Ordinance are not law and may not be considered to have been enacted as a part of this or any prior Ordinance.

Section 3. And be it further ordained, That this Ordinance takes effect on the 30<sup>th</sup> day after the date it is enacted.
