### A Bill Entitled

Article 31 - Transit and Traffic Section 10-19(a) Baltimore City Code (Edition 2000)

By repealing and reordaining, with amendments Parking Management Plan Restatement for Residential Permit Parking Area 18 - Middle/East/South Section I Baltimore City Parking Authority (March 10, 2014)

Section 1. Be it ordained by the Mayor and City Council of Baltimore, That Section I of the Parking Management Plan for RPP Area 18 - Middle / East / South (March 10, 1014) read as follows:

#### Residential Permit Parking Program Parking Plan Restatement RPP Area 18 - Middle/East/South

I. A Residential Permit Parking Program Area known as Area 18, governed by Article 31, Subtitle 10, of the Baltimore City Code, exists for the block faces of the streets listed below:

400 block of North Castle Street, both sides, both sides posted 500 block of North Castle Street, both sides, both sides posted 600 block of North Castle Street, both sides, both sides posted 400 block of North Chapel Street, both sides
