For the purpose of permitting, subject to certain conditions, the establishment, maintenance, and operation of a banquet hall on the property formerly known as 4339 York Road, which is now a portion of the property known as 4335-4339 York Road (Block 5211, Lot 012), as outlined in red on the accompanying plat; and making this ordinance subject to a certain contingency.

**Section 1. Be it ordained by the Mayor and City Council of Baltimore**, That permission is granted for the establishment, maintenance, and operation of a banquet hall on the property formerly known as 4339 York Road, which is now a portion of the property known as 4335-4339 York Road (Block 5211, Lot 012), as outlined in red on the plat accompanying this Ordinance, in accordance with Baltimore City Zoning Code §§ 5-201(a), 14-302, and Table 11-301 (contingent on the enactment of Council Bill 19-0335), subject to the condition that the banquet hall complies with all applicable federal, state, and local licensing and certification requirements.

**Section 2.** And be it further ordained, That as evidence of the authenticity of the accompanying plat and in order to give notice to the agencies that administer the City Zoning Ordinance: (i) when the City Council passes this Ordinance, the President of the City Council shall sign the plat; (ii) when the Mayor approves this Ordinance, the Mayor shall sign the plat; and (iii) the Director of Finance then shall transmit a copy of this Ordinance and the plat to the Board of Municipal and Zoning Appeals, the Planning Commission, the Commissioner of Housing and Community Development, the Supervisor of Assessments for Baltimore City, and the Zoning Administrator.

**Section 3.** And be it further ordained, That this Ordinance takes effect on the 30<sup>th</sup> day after the date it is enacted, contingent on the taking effect of Council Bill 19-0335, the Ordinance that provides that banquet halls are allowed as a conditional use requiring approval by Ordinance of the Mayor and City Council in the I-MU

Zoning District. If Council Bill 19-0335 does not become effective, this Ordinance will be abrogated and of no further effect.
