By authority of

Article 5 - Finance, Property, and Procurement Section 20-2 Baltimore City Code (Edition 2000)

Section 1. Be it ordained by the Mayor and City Council of Baltimore, That the name of Fairmount Harford Building (School #456), located at 2555 Harford Road, is changed to Lake Clifton Park Building (School #456).

Section 2. And be it further ordained, That this Ordinance takes effect when it is enacted.
