**Section 1. Be it ordained by the Mayor and City Council of Baltimore,** That the name of Fairmount Harford Building (School #456), located at 2555 Harford Road, is changed to Lake Clifton Park Building (School #456).

**Section 2. And be it further ordained,** That this Ordinance takes effect when it is enacted.
