Section 1. Be it ordained by the Mayor and City Council of Baltimore, That the Laws of Baltimore City read as follows:

Baltimore City Code

Article 28. Taxes

Subtitle 25. Public Utilities

Part 2. Energy Tax

§ 25-12. Tax imposed.

There is levied and imposed a tax on energy delivered through pipes, wires, or conduits to all users in the City other than those exempted by this Part.

§ 25-12.1. Dedication of tax proceeds.

\$2.5 million of the proceeds from the tax imposed by this subtitle shall be deposited in the continuing, nonlapsing fund created by authority of City Charter, Article I, § 15 {"Special fund for fair elections"}, to be used exclusively for the purposes specified in that section, subject to appropriation pursuant to the annual Ordinance of Estimates.

Section 2. And be it further ordained, That the catchlines contained in this Ordinance are not law and may not be considered to have been enacted as a part of this or any prior Ordinance.

Section 3. And be it further ordained, That this Ordinance takes effect on the date of enactment.
