A Bill Entitled

An Ordinance concerning

City Streets - Naming an Unnamed Alley, Located in the Rear of 216 East Biddle Street, Mura Alley For the purpose of naming an unnamed alley, located in the rear of 216 East Biddle Street, between Hunter Street and Guilford Avenue, Mura Alley.

By authority of

Article 26 - Surveys, Streets, and Highways Section 7-3 Baltimore City Code (Edition 2000)

Section 1. Be it ordained by the Mayor and City Council of Baltimore, That the unnnamed alley, located in the rear of 216 East Biddle Street, between Hunter Street and Guilford Avenue, is named Mura Alley.

Section 2. And be it further ordained, That this Ordinance takes effect on the 30<sup>th</sup> day after the date it is enacted.
