For the purpose of recognizing Councilmember Shannon Sneed for her service to Baltimore City.

Recitals

Councilmember Shannon Sneed faithfully and dutifully represented the 13th Council District from 2016 to 2020. On the Council, she served as Chair of the Labor Committee where she worked to improve working conditions for all Baltimoreans, especially women.

Councilmember Sneed sponsored the "Displaced Service Workers Protection Act," which protected service workers' jobs when new businesses took over contracts. She made Baltimore a pioneer in providing rights and support for women in the workforce with the "Lactation Accommodations in the Workplace" bill. Through this bill, women are able to have space and time for lactation breaks in the workplace.
