Article VI - Board of Estimates

Section 10(b)

Baltimore City Charter

(1996 Edition)

Section 1. Be it ordained by the Mayor and City Council of Baltimore, That

(a) The annual salary of the Director of Public Works, an appointed municipal officer who also serves as a member of the Board of Estimates, shall be \$245,000.

(b) This salary takes effect with the first pay period following the effective date of this Ordinance.

Section 2. And be it further ordained, That this Ordinance takes effect on date it is enacted.
