**Section 1. Be it ordained by the mayor and city council of Baltimore,** That the name of Calverton Elementary/Middle School, located at 201 North Bend Road, is changed to Katherine Johnson Global Academy.

**Section 2. And be it further ordained,** That this Ordinance takes effect on the 30<sup>th</sup> day after the date it is enacted.
