## City of Baltimore Council Bill

Introduced by: Councilmember Dorsey

A Bill Entitled

An Ordinance concerning

**Limiting the Range of City-Owned Take-Home Vehicles**

For the purpose of solely allowing a user of a City-owned take-home vehicle to drive the vehicle within the confines of Baltimore City; and authorizing City agencies to adopt implementing rules and regulations.

By adding

Article 1 - Mayor, City Council, and Municipal Agencies

Section 7-12

Baltimore City Code

(Edition 2000)

**Section 1. Be it ordained by the Mayor and City Council of Baltimore,** That the Laws of Baltimore City read as follows:

**Baltimore City Code**

**Article 1. Mayor, City Council, and Municipal Agencies**

**Subtitle 7. City Officers and Employees**

**§ 7-12. Range of City-owned take-home vehicles.**

(a) *“City-owned take-home vehicle” defined.*

“City-owned take-home vehicle” means a vehicle owned by the City that a City-employee is authorized to use for commuting, as well as other purposes.

(b) *In general.*

A City-owned take-home vehicle may only be used within the confines of Baltimore City.

(c) *Rules and regulations.*

Subject to Title 4 {“Administrative Procedure Act - Regulations”} of the City General Provisions Article, the Director of an agency that provides at least 1 employee with a City-owned take-home vehicle shall adopt rules and regulations to implement this section.

**Section 2. And be it further ordained,** That this Ordinance takes effect on the 30<sup>th</sup> day after the date it is enacted.
