**Section 1. Be it ordained by the Mayor and City Council of Baltimore,** That the Laws of Baltimore City read as follows:

**Baltimore City Code**

**Article 22. Retirement Systems**

**Fire and Police Employees' Retirement System**

**§ 30. Definitions.**

In this subtitle, unless a different meaning is plainly required by the context, the following words and phrases have the meanings indicated:

...

(9) "Regular interest" means interest compounded annually for the reserves and items listed at the following rates:

(i) the Annuity Savings Reserve: 3.0%.

(ii) for valuation purposes:  
[7.25%]

(A) for determining system funding contributions to be made by the City on or after July 1, 2022: 7.0%.

- (B) for determining system funding contributions to be made by the City on or after July 1, 2023: 6.95%.
- (C) for determining system funding contributions to be made by the City on or after July 1, 2024: 6.9%.
- (iii) for determining actuarial equivalents: 5.0%.

**Section 2. And be it further ordained,** That this Ordinance takes effect on the date it is enacted.
