Article 7 - Natural Resources Section 54-7 Baltimore City Code (Edition 2000)

**Section 1. Be it ordained by the Mayor and City Council of Baltimore**, That the Laws of Baltimore City read as follows:

### **Baltimore City Code**

#### **Article 7. Natural Resources**

#### **Subtitle 54. Youth Athletic Protection**

### § 54-7. EMS Presence.

A youth sports program must have an emergency medical technician or paramedic from the Baltimore City Fire Department's Emergency Medical Services Division present at all football games in which youth athletes participate.

**Section 2.** And be it further ordained, That this Ordinance takes effect on the 30<sup>th</sup> day after the date it is enacted.
