**Section 1. Be it resolved by the Mayor and City Council of Baltimore**, That the City Charter is proposed to be amended to read as follows:

#### **Baltimore City Charter**

## Article V. Comptroller

# § 4. Department of Real Estate - Established.

There shall be a Department of Real Estate, the head of which shall be the [Comptroller] Director of the Department of Real Estate, who shall be appointed by the Comptroller.

For the conduct of the Department, the [Comptroller] Director shall appoint [a Real Estate Officer] real estate agents [and such assistants] and such employees as may be provided for in the Ordinance of Estimates.

**Section 2.** And be it further resolved, That this proposed amendment to the City Charter be submitted to the legal and qualified voters of Baltimore City, for adoption or rejection, in accordance with Article XI-A, § 5 of the Maryland Constitution, in the form specified by the City Solicitor.
