## City of Baltimore Council Bill

### A Bill Entitled

An Ordinance concerning **Recordation and Transfer Taxes - Yield Excise Tax - Transactions Assessed** For the purpose of amending which transactions are assessed the Yield Tax; and providing for a special

effective date.

By repealing and re-ordaining, with amendments Article 28 - Taxes Section 17.1-2(a) Baltimore City Code (Edition 2000)

Section 1. Be it ordained by the Mayor and City Council of Baltimore, That the Laws of Baltimore City read as follows:

**Baltimore City Code** 

### Article 28. Taxes

### Subtitle 17.1. Recordation and Transfer Taxes - Yield Excise Tax

### § 17.1-2. Transactions assessed; Tax rate.

(a) Transactions assessed.

The Yield Tax shall be assessed on those transactions whose value exceeds [\$1 million] \$750,000.00, as determined by Subtitles 16 and 17 of this article for the purposes of calculating the recordation and transfer taxes respectively.

Section 2. And be it further ordained, That this Ordinance takes effect on the date it is enacted.
