The City Council would like information on the current process being used to provide City agencies with the resources they need, updates regarding any ongoing efforts to streamline the process, and any potential innovations that could be implemented to help Baltimore City agencies continue to deliver exceptional service to the public while promoting transparency, fairness, social inclusion, and sustainability
