and is no longer needed for public use; and providing for a special effective date.

Section 1. Be it ordained by the Mayor and City Council of Baltimore, That, in accordance with Article V, § 5(b) of the City Charter, the Comptroller of Baltimore City may sell, at either public or private sale, all the interest of the Mayor and City Council of Baltimore in the property located at 1630 North Patterson Park Avenue (Block 1471; Lot 019A), containing 1.089 acres, more or less, and improved by a 3 story building, previously utilized as a manufacturing building, containing 64,000 square feet, more or less, this property being no longer needed for public use.

Section 2. And be it further ordained, That no deed may pass under this Ordinance unless the deed has been approved by the City Solicitor.

Section 3. And be it further ordained, That this Ordinance takes effect on the date it is enacted.
