Section 1. Be it ordained by the Mayor and City Council of Baltimore, That the Laws of Baltimore City read as follows:

Baltimore City Code

Article 1. Mayor, City Council, and Municipal Agencies

Subtitle 41. Civil Citations

§ 41-14. Offenses to which subtitle applies - Listing.

Subtitle 34. Minors - Daytime and Nighttime Curfews

§ 34-9. Penalties.

(b) *Operator of establishment.*

Any operator of an establishment and any agent or employee of any operator who violates any provision of § 34-6 {"Prohibited conduct of establishments"} of this subtitle is guilty of a misdemeanor and, on conviction, [is subject to a fine of not more than ~~\$500~~] shall be fined no less than \$1,000 for each violation.

Section 2. And be it further ordained, That this Ordinance takes effect on the 30th day after the date it is enacted.
