For the purpose of establishing the salary of the City Solicitor; and providing for a special effective date.

Article VI - Board of Estimates

Sections 10(b)

Baltimore City Code

(Edition 2000)

**Section 1. Be it ordained by the Mayor and City Council of Baltimore, That:**

- (a) The annual salary of the City Solicitor, an appointed municipal officer who also serves as a member of the Board of Estimates, shall be \$245,000.
- (b) This salary takes effect with the first pay period following the effective date of this Ordinance.

**Section 2. And be it further ordained,** That this Ordinance takes effect on the date it is enacted.
