FOR the purpose of increasing the fee for permit or certificate applications that require the submission of plans or drawings.

BY repealing and reordaining, with amendments Article - Building, Fire, and Related Codes Section(s) 2-103 (BC § 109.5.7) Baltimore City Revised Code (Edition 2000)

SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That the Laws of Baltimore City read as follows:

109.5.7 Application fee. Before an application for any permit or certificate is processed, the applicant must pay a nonrefundable application fee as follows:

B.	ALL OTHERS		\$150
